We view our agreement as a partnership. Bring us the nicest articles from your closet and we will do our best to sell them for you! Our contract period is for 60 days. Between 60 - 65 days, your items should be picked up, if desired. You can reclaim unsold items, but it is solely the responsibility of the consignor to come in prior to the agreement ending to pick up those items. After 65 days, all items will become property of The Sassy Peacock. At this point, we may donate the items based on inventory levels. If damage or flaws are found during the pricing of your items we will donate them to local charities (these items will not be returned) unless it is priced at \$24.99 or higher, then you will receive a phone call for pick up or donation preference. We donate to the Mercy Center for Women and The City Mission.

We accept upscale ladies, mens and juniors clothing and accessories including: formal wear, shoes, purses, and jewelry. All items must be on HANGERS, in style (no more than 2 years old), in season, cleaned, pressed and odor-free. Brand and size labels must still be intact in original condition. Formal wear needs to be dry-cleaned. We select items based on current styles, condition, brands and inventory levels. We also except accent furniture pieces and home décor items that are in excellent to good condition.

Pricing is determined by The Sassy Peacock to best sell your item(s) at the most profitable price. Items may be reduced at the discretion of The Sassy Peacock at any time. **Please Note:** At the end of each season, items will be clearance up to 50% off to make room the next season's merchandise. All Holiday items, regardless of consignment start date, will be reduced to 50% off the day after the holiday. The Sassy Peacock reserves the right to decline merchandise at its own discretion.

Your itemized inventory sheet will have prices listed. A small buyer's fee, paid by the person who purchases the item, will be added to the price. It will not affect your share. You receive one-half of the price listed on your receipt, or forty percent for items priced under fifty dollars, less any regularly scheduled markdowns. We only offer cash buyouts for costume jewelry. You are welcome to pick up money owed to you at any time. Checks will be mailed for amounts over \$50 at the end of each month. A one dollar processing fee will be deducted from your account for each mailed check. We offer a 10% discount if you shop with your consignment earnings (your balance must cover your purchase).

While every reasonable effort will be made by The Sassy Peacock, LLC to safeguard consigned merchandise at 845 Pittsburgh Ave., The Sassy Peacock assumes NO liability for the loss, damage to, or destruction of any consigned item(s) by fire, theft, accident, or any other cause. When deemed necessary, the policies of the contract may be revised at the owners' discretion. Consignors will be notified. Accounts that have a \$5 balance or less at the end of the year and have had no activity in the last 6 months are automatically closed. All transactions and resolutions to disputes will take place in Erie, PA, USA. Please kindly contact us if you move.

Unless otherwise specified, consignor guarantees authenticity of consigned goods and indemnifies The Sassy Peacock, LLC of any damages, fees, and costs that may occur, including return of buyer's purchase price, as a result thereof.
